VICTIM NOTIFICATION

Victims of an offender incarcerated in an Ohio prison or under the supervision of the Adult Parole Authority may register with the Office of Victim Services to receive notifications.

Senate Bill 160, known as “Roberta’s Law”, became effective on March 22, 2013. Roberta’s Law expands victim notification rights enumerated in Ohio Revised Code section 2930.16 as they relate to certain inmate release or transfer proceedings. Victims are encouraged to register for notification or to opt-out of receiving these notifications, outlined below, by contacting the Office of Victim Services.

- The offender’s date to be released from prison.
- Upcoming hearings (including parole and clemency).
- Parole Board recommendations for Transitional Control.
- The offender’s escape from custody.
- The offender’s death.
- The offender’s status regarding transfer to another state for community supervision (Interstate Compact).

Victim Responsibilities:

- **Register for notification with the Office of Victim Services.**
- **Keep the Office of Victim Services informed as to your current address and telephone number.**

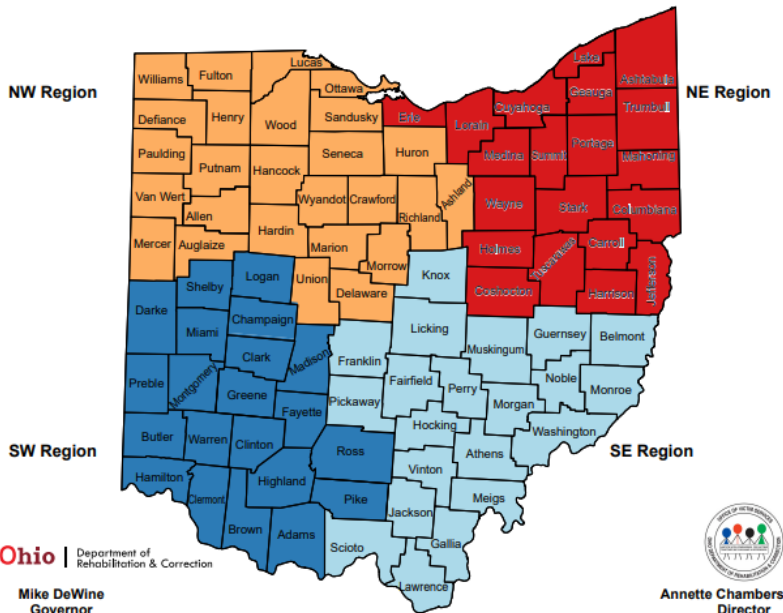
